**ELIGIBILITY CRITERIA AND GENERAL TERMS &
CONDITIONS FOR TENDER**

1. The bids will be submitted in **two separate envelopes** marked as **Technical and Financial** and put in third envelop. All envelopes should be addressed to Principal, J. N. College, Dhurwa, Ranchi. Tender number and date should be mentioned on the envelopes. Properly sealed tender should be submitted in the office of the undersigned either in person or by registered post on or before **04.01.2021** till **2.00pm**. **Tender received after due date and time, whatever be the reason, will be rejected/not accepted.**
2. The bidder should be an ISO Certified OEM (Original Equipment Manufacturer) or their Authorized dealer/partner. In case of authorized dealer/ partner, a letter of authorization (Original copy with seal and stamp) from original manufacturer must be furnished.
3. The bidder shall append a certificate with the quotation/ tender that the firm has not been debarred/ blacklisted for any reason/ period by any central/ state govt. dept./ University/ PSU etc. If so, particulars of the same may be furnished. Concealment of facts shall not only lead to cancellation of the order, but may warrant legal action.
4. PAN , TAN , VAT/GST No (as applicable) details are to be submitted with the bid.
5. The Bidder should be registered with VAT/GST for the last five years in Jharkhand. Certified copy of GST Registration Certificate, GEM Registration, Credentials, etc. together with latest GST return copy are to be enclosed with the bid. (submit self-attested documents)
6. Annual Turnover of the bidder should be **Rs. 50 Lakhs** and above in the last three Financial years and should have been audited by a chartered accountant. The tender must **enclose copy of Income tax return** for the last 3 financial years.
7. The Firm submitting Tender should have a minimum experience of three consecutive years of supply and successful installation of Sound Less Diesel Gen Set. (Self-attested Copy of work experience from the institutions should be attached)

8. Certified copy of CPCB-II should be attached.
9. Bidder should have local registered office & OEM service center in Jharkhand. (Submit self-attested documents.)
10. **The tenderer/ bidder are required to deposit earnest money of Rs. 10,000 (Rupees Ten Thousand) in the form of Demand Draft from any scheduled bank in favour of the Principal, J.N. College, Dhurwa.**
11. Price must be quoted in Indian rupees inclusive of all taxes and typed in both word and figure. Typing errors or cutting must be countersigned by due initial with date. Non-compliance or overwriting will lead to rejection of quotation.
12. The Price of items in full and complete set including all parts and inclusive of supply, **installation**, commissioning, packaging, **transportation** along with all taxes & **GST** etc. (as applicable) has to be mentioned.
13. If bidder desires to withdraw before bid submission closing date/time, he may do so and in that case EMD would be refunded but **not** the cost of the tender (Rs. 2000/-). Once withdrawn he/she cannot participate again in this tender.
14. EMD is to remain valid for a period of **Ninety (90)** days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them after the award of the contract.
15. The Bid Security of the successful bidder would be returned, without any interest after the receipt of Performance certificate from the competent team constituted by college.
16. Price in the quotation must be valid up to 180 days from date of submission of quotation.
17. **The technical bids shall be opened on 06.01.2021 at 11.30 AM in the office of undersigned. The Financial Bids will be opened only of those Bidders whose technical bids meet the required minimum Technical specifications. Work order will be given to the bidder whose quoted price is found the lowest i.e. to L1.**

18. Supply is to be provided within 15 days from date of issue of order. The College may forfeit the EMD if bidder fails to supply all the items within stipulated time period.
- 19. Payment shall be made after quality and quantity of items supplied is verified and certified by a competent team constituted by the college.**
20. After successful installation by bidder, technical support will be provided as and when required for duration of 36 (thirty six) months. A warranty is to be submitted along with bid.
21. All the interested bidders are required to see Notice Board/ Website of the college for any further change/corrigendum and proper understanding of the requirement.
22. In case of any confusion in the interpretation of any word/sentence, the decision of the tendering authority will be final.
23. The college reserves the right to cancel the tender process or accept or reject any tender without assigning any reason.
